Warrants that C-3000 Series Colour Products manufactured by Designer Concrete Coatings Pty Ltd are good and fit for their intended purpose conforming to relevant Standards Australia/New Zealand Test Methods and in compliance with relevant Statutory State & Territory obligations governing non-structural building elements of commercial construction; and, shall be free of manufacturing faults and/or defective materials at the point of sale.

If for the limited statutory warranty period of **two (2) years** in accordance with non-structural building elements; and, from the completion date of installation of the C-3000 Colour Product used in conjunction with the construction purpose of a **normal light traffic commercial driveway or pathway** the C-3000 Colour Product is proven to be faulty or defective as a direct result of manufacturing processes or raw materials then it shall be replaced or repaired at the discretion of Designer Concrete Coatings Pty Ltd.

This Warranty is limited to the Product and explicitly excludes failure or damage resulting from improper workmanship or installation methods not recommended by Designer Concrete Coatings Pty Ltd which are the statutory warranty responsibility of the independent entity contracted to carry out the works; abuse of pavement owners' normal maintenance requirements, the construct of any supporting substrate, using the driveway or pathway for any other purpose than for light traffic commercial use and/or exceeding the design traffic loads applicable to the pavement construction, damage or discolouration or stains caused by external agents or materials, accident, defective sub-grades, movement of the sub-base/ground, concrete cracking, fire, flood, earthquake or other act of God, or the performance of any sealer materials used in conjunction with C-3000 Colour Products for which no guaranteed is or can be given.

The completion date of the work and proof of product purchase and product payment must be documented by the independent entity contracted to do the work and the pavement owner on the form below and returned to Designer Concrete Coatings Pty Ltd within 30 days after completion of the work for any warranty claim to be considered.

This warranty is between Designer Concrete Coatings Pty Ltd and the pavement owner conditional upon full payment for the work and is not transferable to any other party and is strictly limited to whole use of materials manufactured by Designer Concrete Coatings Pty Ltd in the performance of the surface-formed decorative concrete works. Use of substitute materials in whole or in part will void this warranty.
